

PRIVACY POLICY

This is the Privacy policy of FAECTOR, which is located in Rotterdam, registered to the Dutch Chamber of Commerce (Kamer van Koophandel) under number 40346076. This Privacy policy explains which data FAECTOR collects from its members and how this data is processed, treated, stored and deleted. Informing members and having them agree to this process is mandatory under the General Data Protection Regulation (GDPR), which is a European Law per May 25, 2018.

If you wish to become a member of FAECTOR, this Privacy policy must be agreed upon by actively ticking the box referring to it on the registration form, for either becoming a FAECTOR member, an external member or a FAECTOR Alumni Network (abbreviated as FAN, previously called RECNET) member.

1 Use of personal data and data retention policy

FAECTOR will only use your personal information to make sure that we can enrich your life as an econometrician in the broadest sense of the word. We will never use your personal information for anything else than our association's purposes or store this data longer than is strictly necessary. FAECTOR will store your personal data for the entire duration of your FAECTOR membership and if applicable, for the entire duration of your FAN membership.

As a member of FAECTOR or FAN, you have the right to get insight into what we know about you, what information we store and why we do that, which can be found in this document.

- 1) We ask personal data when you:
 - a) Become a member of FAECTOR by means of registering through the FAECTOR website
 - b) Become a member/contributor of our FAECTOR Alumni Network by means of registering through the FAECTOR website
 - c) Acquire an external account through the FAECTOR website
 - d) Subscribe for an event via:
 - i) The FAECTOR website
 - ii) The ECD Rotterdam website / Financial Markets Tour / ICansultancy website

Personal information that we gather from the Econometric Career Days, Financial Markets Tour (previously called Quantitative Finance Tour) and ICansultancy website will be treated the same as for the FAECTOR website.

- 2) We gather the following data:
 - a) Name + surname
 - b) Gender
 - c) Date of birth
 - d) Nationality
 - e) E-mail address
 - f) Phone number
 - g) Address
 - h) Bank account number (IBAN)
 - i) Study and study start year
 - j) CV, motivation letter and grades (only for committee applications or career events)
 - k) Scan of passport or identity card (only if you're participating in a FAECTOR trip abroad)
 - I) Attendance at FAECTOR events
 - m) Profile picture
- 3) We use this data (possibly):
 - a) Name + surname: to identify you as member and to confirm that you are enrolled at the Erasmus University Rotterdam, and to state you as a member in our annual almanac memberlist
 - b) Gender: to identify you as member
 - c) Date of birth: mainly to check whether you are allowed to drink alcohol at FAECTOR events, such as trips abroad, social drinks and parties
 - d) Nationality: to know whether you qualify for our iBuddy programme
 - e) E-mail address: to contact you after enrolling for an event and to send you newsletters and commercial mailings
 - f) Phone number: to contact you if you did not show up for an event that you were enrolled for without any reason and to call you to verify if you are still coming to a career event like the Econometric Career Days
 - g) Address: to send out physical mail
 - h) Bank account number (IBAN): to collect the annual membership costs
 - i) Study and study start year: to identify you as a member, and to state you as a member in our annual almanac memberlist

- j) CV, motivation letter and grades: for committee applications or career events. These documents will be deleted once the event is over or when the committees are announced.
- k) Scan of passport or identity card: needed when you're participating in a FAECTOR trip abroad. This document will be deleted once the event is over.
- Attendance at FAECTOR events: for data analytics and occasionally for selecting participants for events with motivation and cv selection (e.g. previous participance is taken into account when selecting the Business Trip group)
- m) Profile picture: to state you as a member in our annual almanac memberlist

2 Photos and videos

During events, it is possible that we take photos or record video. This graphic material is used exclusively for promotion via social media (Facebook, Instagram, TikTok), our website, our news platform the Estimator, physical media and we might send it to the Erasmus University Rotterdam (EUR) or the Erasmus School of Economics (ESE). 4 Almanac

We yearly publish a memberlist in our almanac, which states your name, surname, start year, study phase (Bachelor or Master) and your profile picture of the website. However, we will ask you yearly before the almanac is published whether you would want to refrain from the almanac.

5 Third parties

We can share your personal data, including CV and motivation letters, with our partners and companies we have a relation with. However we will never do this without your consent, hence we ask you to actively agree to share this information with aforementioned third parties when you sign up for a career event where uploading your CV is required.

If you do not agree to share your personal data with third parties, we cannot guarantee that you are able to participate in career events such as inhouse days or company dinners.

6 Security

We are committed to ensuring that your information is secure. In order to prevent unauthorized access or disclosure, we have put in place suitable physical, electronic and managerial procedures to safeguard and secure the information we collect online.

If there is any form of a personal data breach that has an influence on you, you will be notified without undue delay.

7 FAECTOR Alumni Network (previously called RECNET)

After you've graduated, you have the option to become a member of the FAECTOR Alumni Network (abbreviated as FAN). If you wish to become a member or to get updates on FAN activities and occupations, we will transfer your personal data from your FAECTOR account to your FAN account. If you do not want to become a member or get updates from FAN, you will be removed from our database.

8 Adjustments privacy policy and other questions

It is possible this privacy policy will be changed in the future. Hence, we encourage you to regularly check this privacy policy.
